Library Cardholder's Statement of Responsibility

4. Adult cardholders and parent/or guardians of minor cardholders acknowledge and agree that they are responsible for loss, theft, damage charges or other expenses related to materials borrowed by minors, on such card. A billing fee will be charged by any accounts referred to our material recovery service.
5. Adult cardholders and parents/or guardians of minor cardholders acknowledge and agree that they are responsible for violations to rules or regulations by minor children who are cardholders or borrowers on any card.
6. Parents/or guardians acknowledge that they are solely responsible for selection of library materials and use of library borrowing privileges and the library card by their minor child.
